ORDER

1. Whereas, the AICTE is a statutory body established by AICTE Act, 1987. The said Act "provides for establishment of an All India Council for Technical Education with a view to the proper planning and coordinated development of the technical education system throughout the country, the promotion of qualitative improvement of such education in relation to planned quantitative growth and the regulation of proper maintenance of norms and standards in the technical education system and for matters connected therewith."
2. Whereas, Section 10 of the AICTE Act prescribes the function of the Council and mandates that it shall be the duty of the Council to take all necessary steps as it may think fit for ensuring coordinated and integrated development of technical education and maintenance of standards. Further, Section 10 (k) of the AICTE Act, empowers the AICTE to grant approval for starting new Technical Institutions and for introduction of new courses or programmes in consultation with the agencies concerned.
3. Whereas, in order to discharge its duties in accordance with the provisions contained in the AICTE Act the AICTE has framed the regulations for grant of approval for starting new Technical Institutions, introduction of courses or programmes and increase / variation of intake capacity of seats for the courses or programmes of existing Technical Institutions. The AICTE has also evolved a Hand book for approval process which details out the procedure as well as minimum conditions which an Institute must fulfill in order to seek approval for either starting new Technical Institutions or for introduction of courses / programmes as increase / variation of intake capacity of seat for courses / programmes as well as existing Technical Institute.
4. Whereas, **Prem Prakash Gupta Institute of Engineering 16.1 KM. Stone, Bareilly Lucknow Road Bareilly Uttar Pradesh 243201 was approved in the A.Y 2009-10 for running Engineering & Technology & Management programmes and subsequent extension of approvals were issued up to A.Y. 2017-18.**
5. Whereas, the Council conducted a surprise visit to the institute on **28.10.2017**, which brought out various deficiencies with regard to building/ built-up / instructional / administrative/ amenities area/ faculty or anti- ragging etc. The report of the EVC was uploaded on the portal.
6. Whereas, the Institute was intimated through web portal to appear before the SHC on **08.11.2017** at AICTE HQ alongwith supporting documents/evidence in compliance to the deficiencies. Representative of the Institute appeared before the Committee on the scheduled date and the SHC recommended that the Institute be placed under "NO Admission" category for the A/Y 2018-19.
7. Whereas, a Speaking Order dated 23-11-2017 was issued to the Institute conveying the decision of SHC. The Institute appealed for consideration by SAC. The SAC held on 14-02-2018 and the Committee observed the following:-

Recommendations of the SHC:-

“The SAC observed that the institution does not have qualified Director/Principal, there is shortage of faculty (available faculty is less than 50%) and other deficiencies in infrastructure, salary paid is not according to VI pay commission, online transactions are not made. No document with respect to barrier free environment was produced.

In view of above gross shortcomings the committee recommend “No Admission”.

8. Therefore, after examining the entire matter in the facts and circumstances mentioned herein above, and in terms of the provisions of the Approval Process Hand Book for the A/Y 2018-19 and also the terms and conditions mentioned in the Letter of Approval, it has been decided that **Prem Prakash Gupta Institute of Engineering 16.1 KM. Stone, Bareilly Lucknow Road Bareilly Uttar Pradesh 243201** be placed under “No EOA/No Admission” category for the academic year 2018-19. Accordingly, the above decision has been implemented on AICTE web portal in respect of the institute for AY 2018-19.
